1. All citizens wishing to speak must first be recognized by the Chairperson.
2. The Chairperson will not call for public comments on an item until after a motion has been made and seconded and the board has had adequate opportunity to discuss the item.
3. Please stand and clearly state your name and address after being called on to speak.
4. All comments must be directed to the Chairperson.
5. **TIME LIMIT – THREE MINUTES PER PERSON PER ITEM.** (If a person needs more than three minutes, prior arrangements must be made with the District Secretary).
6. Statements should not be repetitive.

1. Call to order and roll call.
2. Call to Public.
3. Approval of Minutes: Budget Workshop and Regular Meeting: May 22, 2024.
4. Consideration to approve Resolution No. 294, the FY 2024/2025 fee schedule. (TM)
5. Consideration to approve FY 2024/2025 budget. (TM)
6. District Manager's report: items to be discussed include plant, recycled water, and recharge statistics for May, permit compliance, new sewer services, active project updates, public communication efforts, and Town communication and/or coordination efforts. (DT)
7. District CPA's report: items to be discussed include status of income and expenditures, billing, report on collection efforts to date, and general direction from Board. (TM)
8. Legal Counsel updates and discussion of procedural matters and possible future legislation. (DJ)
9. Discussion and consideration to authorize the purchase of a replacement portable generator used at pump stations after July 1, 2024 in the amount of \$63,125. (DT)

10. Discussion and consideration to authorize a work task order after July 1, 2024 to Carollo Engineers to update and convert the District's sewer hydraulic model in the amount of \$39,050. (DT)


